

4. The institutions shall ensure the fulfillment of the following :-
- The institutions shall maintain the teaching staff strength of 1+7 for the sanctioned B.Ed. course, 1+3 for M.Ed. 25 intake and all the appointments would be on regular basis on an approved scale of payment of the candidates having fulfilled eligibility condition prescribed by NCTE. The institute concerned shall send a report in this regard to WRC of NCTE within 30 days, in terms of clause 7 (12) of the NCTE Regulations 2005.
  - The institutions shall note that with regard to NET / SLET requirement, the relaxation is allowed only upto the year 2009-2010 as per NCTE Regulation dt. 21.7.2006.
  - The institutions shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.

- iii) As per Supreme Court order dated 16/03/2007 in CA No. 4455/2007 in Special Leave Petition (SLP) Civil No. 4361/2007, the Vice Chancellor vide Order No. Aff.Gen-1/Bhartiya Gramin/ 2007-08/69 dated April 12, 2007 has granted the First Time Affiliation to the B.Ed. Course (Marathi Medium), Conducted by the Bhartiya Gramin Punarachana Sanstha's College of Education, Plot No.P-75, Behind Garware Polyester, Chikalthana M.I.D.C., Aurangabad, with intake capacity of 100 students at Aurangabad, for the academic year 2006-07.

The First Time of Affiliation is granted, subject to the submission of written undertaking by the Trust, agreeing to fulfill all the condition of affiliation as stipulated under section 81, 82 and 83 of the Maharashtra University act, 1994, within prescribed time limit and that on default, the First Time Affiliation so granted shall be withdrawn/terminated, as per the produced laid down for the purpose.

It may be noted that, the First Time Affiliation has been granted for one academic year (i.e. June, 2006 –May, 2007) to teach the following subject/methods at the B.Ed. degree course.

The First Time Affiliation to the Bachelor of Education course for the academic year 2006-07 is granted on the following terms and conditions:


1. The joining report of the above faculty, needs to be submitted to the University within one month from the receipt of this letter.
2. That the Trust / Sanstha / Mandal / Society shall appoint the following staff, as per the qualifications and procedures prescribed by the University Grants Commission/University:
  - i. Teaching staff including Principal
  - ii. Librarian
  - iii. Non Teaching staff
  - iv. Technical/Laboratory Staff, wherever applicable
3. That the Trust/Sanstha/Mandal/Society shall meet the financial deficits, if any, by making an outright grant to the College from its own funds.
4. That the Trust shall maintain the rosters for reservation of posts of teaching and non-teaching staff, as per the reservation policy of the State Government and maintain service books and the provident fund registers of all employees.
5. That the Trust shall provide facilities for library, books and journals, furniture, fixtures and fittings for class room, office, laboratories, library, and staff room.
6. That the Trust shall constitute the Local Managing Committee, as prescribed under Section 85 of the Maharashtra Universities Act, 1994 (copy enclosed).
7. That the Trust shall comply with the conditions laid down by the concerned State Government with regard to admission of students belonging to SC/ST/DT/NT/OBC categories.
8. That the Trust shall comply with the Orders/directives issued by the Chancellor, the Vice Chancellor and other officers of the University in exercise of the powers conferred on them under the provisions of the Act, Statutes, Ordinances, Rules and Regulations.
9. That the Trust shall send to the University, the progress reports of the compliance of the above conditions from time to time.

10. That the College/Trust shall keep the Fixed Deposit of Rs. 6 Lacs in any Nationalised Bank in an account in the joint name of the Registrar, SNDT Women's University and the Chairman / President of the said Trust for a period of 6 years. This deposit will have to be renewed with the accrued interest for further 6 years at the end of maturity date i.e. after 6 years and the copy of the receipt of the fixed deposit be produced to this University.
11. That the Trust/Sanstha/Mandal/Society shall give an undertaking on stamp paper worth Rs. 100/- wherein it will agree to comply with all the conditions for affiliation laid down under Section 81 of the Maharashtra Universities Act, 1994 and also agree to abide by the rules and regulations as may be framed by the University from time to time.

You are requested to note the same and do the needful and send a copy of the undertaking referred at Sr. No.11 hereinabove urgently.

Revised Order

Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. And whereas, the Bhartiya Gramin Punarachana Sansthas(Bgps),Plot No .-P-75, Midc Industrial Area Chikalthane, Behind Garware Pilyester Ltd. Aurangabad 431210 Maharashtra by affidavit dt. 08.01.2015 has consented to come under new Regulations and sought for two basic units in B.Ed, which require additional facilities

3. And whereas, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,

- I. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
- III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- IV. In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.

4. Now therefore, in the light of the above and in accordance with the NCTE Regulations, 2014, the Western Regional Committee (NCTE) hereby issues the revised recognition order to Bhartiya Gramin Punarachana Sansthas(Bgps),Plot No .-P-75, Midc Industrial Area Chikalthane, Behind Garware Pilyester Ltd. Aurangabad 431210 Maharashtra for conducting B.Ed programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

5. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.

7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- a) Sanctioned programmes along with annual intake in the institution;
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last, quarter;
- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information. if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

8. Recognition order no. WRC/5-6/90/2006/ dt. 28.10.2006 be treated as cancelled from the date of issue of this revised order.


